


### **PARTICIPATION**

#### Members, Non-Member Friends, & Religious Education Enrollment

Membership has been declining about 5% year for the past two years, which is up from the 1% we were seeing prior to the panderr

Non-member friends increased 6% over last year, but is still down 7% from 2020's pre pandemic numbers.

Religious Education Enrollment has been on the decline for the last decade with enrollment failing faster in the years after the pand




### **MEMBERSHIP BY REGION**


#### Membership by Region

All 5 regions are seeing a decline in membership. Over the last year the national decline is 4% with the Southern Region seeing the largest decline of 5% followed by MidAmerica 4%, New England 4%, Pacific Western 6%, and Central East 3%.

The Southern Region was previously the only region with small increases to membership each year from 2013 to 2019.



Western Enlightenment Language

Characterized by:

Political democracy, freedom, universal human rights, legal equality for all adult citizens, freedom of expression, freedom of religion, respect for evidence and reason

Opposes authoritarian movements of all types

The UUA will actively engage its members in the transformation of the world through liberating Love.

### Power and Priorities

- 2020 Action of Immediate Witness
  - Amen to Uprising: A Commitment and Call to Action
    - Deactivate security systems that mobilize police
    - Join in calls for defunding of police
- Congregations may not see a duty toward the Association as a whole, especially when the Association is acting as a change agent. Therefore, a change process driven from the Association to the congregations may be doomed to fail because of the emphasis on congregational autonomy. (RCIC page 48)



### TO WHOM ARE WE ACCOUNTABLE?

Preamble to the Values: "We are accountable to one another for doing the work of living our shared values...."

Current: - Our own conscience as individuals (or to whomever our conscience calls us)

- Judgement and correction are in our hands.

Proposed: "One another"

- Judgement /correction are in the hands of others.

### **Bylaws Renewal Team**

- 2022 Business Resolution: "These new bylaws should create a governance system that supports the UUA in accountably achieving its mission and aspirations consistent with our core values."
- RCIC: "We need a congregational polity that serves us rather than blocks progress." (page 37)
- RCIC: "A change process driven from the Association to the congregations may be doomed to fail because of the emphasis on congregational autonomy." (page 48)

- Censured
- Expelled
  - RCIC: Pages 58,62,74,VISIONS Audit 92-93
- We covenant "collectively"
- ...make sure we are accountable to communities rather than to individuals (RCIC: pages xxiii, 10, 13, 28, 32, 46, 72, 131)

### **Covenants**

"Covenant without consequences is not actually covenant"

"We have to be willing to say 'no' in UU spaces."

To say "you are so out of Covenant, you cannot be back in this community until you're will to do the work of repair."

"We do not wallow in harm until you are" [ready to do the work].




### **Current:**

Nothing herein shall be <u>deemed to infringe</u> upon the individual freedom of belief which is inherent in the Universalist and Unitarian heritages or to conflict with any statement of purpose, covenant, or bond of union used by any congregation unless such is used as a creedal test.

### **Proposed:**

Congregational freedom and the individual's right of conscience are <u>central</u> to our Unitarian Universalist heritage. Congregations may establish statements of purpose, covenants, and bonds of union so long as they do not require that members adhere to a particular creed.


